Rub and then rinse with plenty of water. Rinsing equipment must only be carried out with drinking water at room temperature.

CLEANING A SANITARY BARRIER (WASHING BOOTS): Use a 1.0 to 2.0% solution (dilute to 10 to 20 mL of SH 6000 QUALIFOOD in 1L of water at room temperature) depending on the degree of dirt.
